## **VISION module**

**As you work toward a shared vision for your district, ASBA can help:**

- Implement the Vision Self-Assessment (page 15) and facilitate feedback sessions
- Facilitate survey feedback dialogue sessions
- Design a process to create or revisit your existing Vision Statement, Mission Statement, Values, Belief Statements and Goals
- (Re)visit the roles and responsibilities of the Governing Board and Superintendent in the Vision Planning Process

## **ACCOUNTABILITY module**

**As you determine the best methods for ensuring your students achieve at the highest level, ASBA can help:**
